## **Husky/Mohawk Charitable Rebate Cards**

### **PURPOSE OF THE REBATE CARD**

Husky Oil Marketing has developed a Community Rebate Program whereby a point's card is used to accumulate rebates which are paid back to The Rainbow Society of Alberta.

### **ACCUMULATION OF REBATES**

Group members must present their Husky Community Rebate card at the time of purchase to earn Community Rebates. Eligible purchases include fuel, lubricants, service and repairs, automotive parts, groceries and convenience store items and Husky House Restaurant meals. The Community Rebate card is accepted at participating Husky or Mohawk retail outlets in Canada.

The rebates from each individual card transaction accumulate into the group's account at Husky. Rebates are calculated at 2% of the retail purchase (1% for eligible commercial purchases made at retail). The Community Rebate card is not a form of payment for Husky or Mohawk purchases.

### **INELIGIBLE PURCHASES**

Lottery and tobacco product purchases are not eligible for rebates. The purchase of Husky/Mohawk gas certificates is also ineligible for rebates (however, rebates will be paid for gas certificates being redeemed). Purchases made with Husky Route Commander Cards, or bulk account payments do not qualify for Rebates. The Community Rebate Program is not to be used in conjunction with any other loyalty rewards Program (ie. CAA Program). Community Rebates will not be credited for the GST amount on single transactions over \$1000.00 (on repairs, for example).

### **PAYMENT OF REBATES**

Community Rebates will be paid to participating groups on a quarterly basis as determined by Husky. If the Rebate amount payable is less than \$50, then payment will be rolled over to the next quarter when the rebate amount equals or exceeds \$50.

### **YOUR PERSONAL PRIVACY**

You consent to Husky's collection and use of your personal information and any personal information of individual members of your group that is provided to Husky for the purposes of administration, operation, promotion and evaluation of the Program. Husky agrees to hold all such information in confidence and in accordance with Husky's Privacy Policy. **Question :** Are only members of the organization allowed to use the program, or can friends and families use it as well?

**Answer:** Anyone who wants to use the Program is very welcome to do so. Probably the most frequent users will be members of your organization, but their friends, family members and other supporters of your group are welcome to use it as well.

**Question :** Do customers need identification to use the Program?

**Answer:** No. All they need to do is ask the retailer to run the swipe card through the card reader when they make a purchase.

**Question :** What happens if a member loses their card or has it stolen – are they at risk from someone using it and running up heavy expenses?

**Answer:** Absolutely not. The Husky Rebate Card is not a credit card – you can't run up expenses with it. In the unlikely event that a stranger found a Rebate Card and started using it, all that would happen is your group would get rebate payments from an unexpected source!
